THE PACT (Partnerships for Capability Transformation) programme is definitely welcome. In the past, many SMEs especially those in the supporting industries had benefited from the LIUP (Local Industry Upgrading Programme). Under the LIUP, funding was available for MNCs to assist their SME suppliers to upgrade their capabilities under a formal training and skills upgrading programme.

The stated objective of the PACT programme is to help SMEs develop competencies to meet stringent manufacturing quality and certification requirements of MNCs. As most of our production activities are in China, Pursuit hopes to be able to tap the PACT programme to work with China-based MNCs to upgrade our manufacturing and supply chain capability.

Many local companies are like us. They manufacture components or final products in the region with materials sourced regionally. Over time, increasing competition from the region will force more local companies to adopt similar business models.

Therefore we hope that the PACT programme can benefit SMEs with overseas manufacturing operations. We also hope that the grants would be generous especially for certifications which are usually very costly to acquire. In addition, we hope that the allocation of the grants can be processed expeditiously so as to alleviate SMEs' cash flow problems.

We look forward to more details which the government will unveil in May 2010.

I APPLAUD the government for continuing to support growing SMEs to develop competencies. The LIUP scheme has been effective in helping SMEs in capability development especially when there is a pair-up with MNCs whom SMEs can complement. While many SMEs have benefited from such a scheme, a suggestion for PACT will be to consider cross-industry upgrading.

"Cross-breeding" competencies have a number of benefits. First and foremost, the organisation can take the opportunity to review existing processes and adopt best practices from a different industry. Sometimes, such considerations can help to streamline processes which are kind of "stuck" to old-school thinking. Secondly, "cross-industry practices" would provide an alternative perspective which can possibly provide some considerations to existing deadlocks. Thirdly, "cross-breeding" can also open up new opportunities for new forms of synergy and mutual benefits, such that new competencies to service a common space may be discovered.

Hence, in terms of criteria and administrative requirements for PACT, I hope to see a more flexible and open minded evaluation. If an idea is unheard of before, it does not mean that it will not work. On the contrary, it may will be the dawn of a new competitive effort to increase productivity in both industries.
